Helfrich Men's Club 2018 Match Play Tournament Rules

1. The competition will be Match Play format as prescribed by the Rules of Golf. GPS yardage systems are permitted for players use.
2. Matches shall be 18 holes in length playing the front 9 and back 9 of the Helfrich Golf Course. The same 9 may not be played twice.
3. All matches shall be played from the **Blue Tees**.
4. The first match in each bracket will be determined by a random draw of players. Succeeding matches will follow bracket order.
5. The tournament shall be Flighted based upon handicaps on or about May 9, 2018. The number of flights (i.e. brackets) will be determined based on the number of members participating. Once the brackets have been determined, no changes will be made to the brackets regardless of how handicaps may change over the period of play.
6. Each bracket will consist of at least eight (8), but not more than 16 players.
7. Matches shall be scheduled by and at the convenience of the players. Players must play and finish their match before the scheduled end-date of the given round of matches. *It is highly recommended players schedule their matches as soon as the round period opens to ensure they be able to finish their match within the specified time period.*
8. If players for a given match fail to play their match within the designated time period, the winner of that match will be decided by a coin flip by the Tournament Chairman. It is expected however, that players will make diligent effort to play their match within the time period stipulated. *(Note: Rule 2-4 states "A Player may concede a match at any time prior to the start or conclusion of that match". Therefore, if a player is unable to play his match in the time stipulated he can concede his match to his opponent therefore allowing his opponent to move on in the competition.)*
9. Before each match begins, players must declare their respective handicaps with one another. The higher handicap player will receive the stroke differential on the lowest handicap holes. *[Example: Player A has a course handicap of 15. Player B has a course handicap of 12. Player A will receive the differential of 3 strokes - one stroke each on the #1, #2 and #3 handicap holes.]* The lowest net score on each hole shall decide the winner of the hole.

10. The stipulated round shall be 18 holes. A match is won when one player is up more holes than there are holes left to play. In the event of a tie, a "sudden death" playoff continuing the match play format shall be played until a winner is finally determined. Playoff holes will begin on #1 or #10 at the convenience of the Helfrich Pro Shop and it being able to accommodate the playing of extra holes.

11. No prepared scorecards shall be used or required. When playing their match, players keep track of who is up (or down) holes as the match is played.

12. At the conclusion of each match, the winner shall notify the Tournament Chairman (Nelson Ford) of the outcome via email at brokenteegolf@gmail.com.

13. **Late for tee time:** If a player is late for his tee time, there is a grace period of up to but not more than 5 minutes. If play begins within 5 minutes of the designated tee time, the player arriving late suffers a loss of hole for the 1st hole and play continues and begins on the 2nd hole. If a player is late for his designated tee time more than 5 minutes, he is disqualified.

14. In match play, a putt or hole may be conceded by a player to his opponent at any time and cannot be withdrawn.

15. Concerning disputes, see below from the USGA Rules of Golf:

"In match play, if a doubt or dispute arises between the players, a player may make a claim. If no duly authorized representative of the Committee is available within a reasonable time, the players must continue the match without delay. The Committee may consider a claim only if it has been made in a timely manner and if the player making the claim has notified his opponent at the time (i) that he is making a claim or wants a ruling and (ii) of the facts upon which the claim or ruling is to be based.

A claim is considered to have been made in a timely manner if, upon discovery of circumstances giving rise to a claim, the player makes his claim (i) before any player in the match plays from the next teeing ground, or (ii) in the case of the last hole of the match, before all players in the match leave the putting green, or (iii) when the circumstances giving rise to the claim are discovered after all the players in the match have left the putting green of the final hole, before the result of the match has been officially announced.

A claim relating to a prior hole in the match may only be considered by the Committee if it is based on facts previously unknown to the player making the claim and he had been given wrong information (Rules 6-2a or 9) by an opponent. Such a claim must be made in a timely manner.

Once the result of the match has been officially announced, a claim may not be considered by the Committee, unless it is satisfied that (i) the claim is based on facts which were previously unknown to the player making the claim at the time the result was officially announced, (ii) the player making the claim had been given wrong information by an opponent and (iii) the opponent knew he was giving wrong information. There is no time limit on considering such a claim.

16. Any questions should be directed to the Tournament Chairman - Nelson Ford. The Tournament Chairman and/or the Club Tournament Committee shall resolve any and all disputes. All decisions made by the Chairman and/or Committee shall be final.
