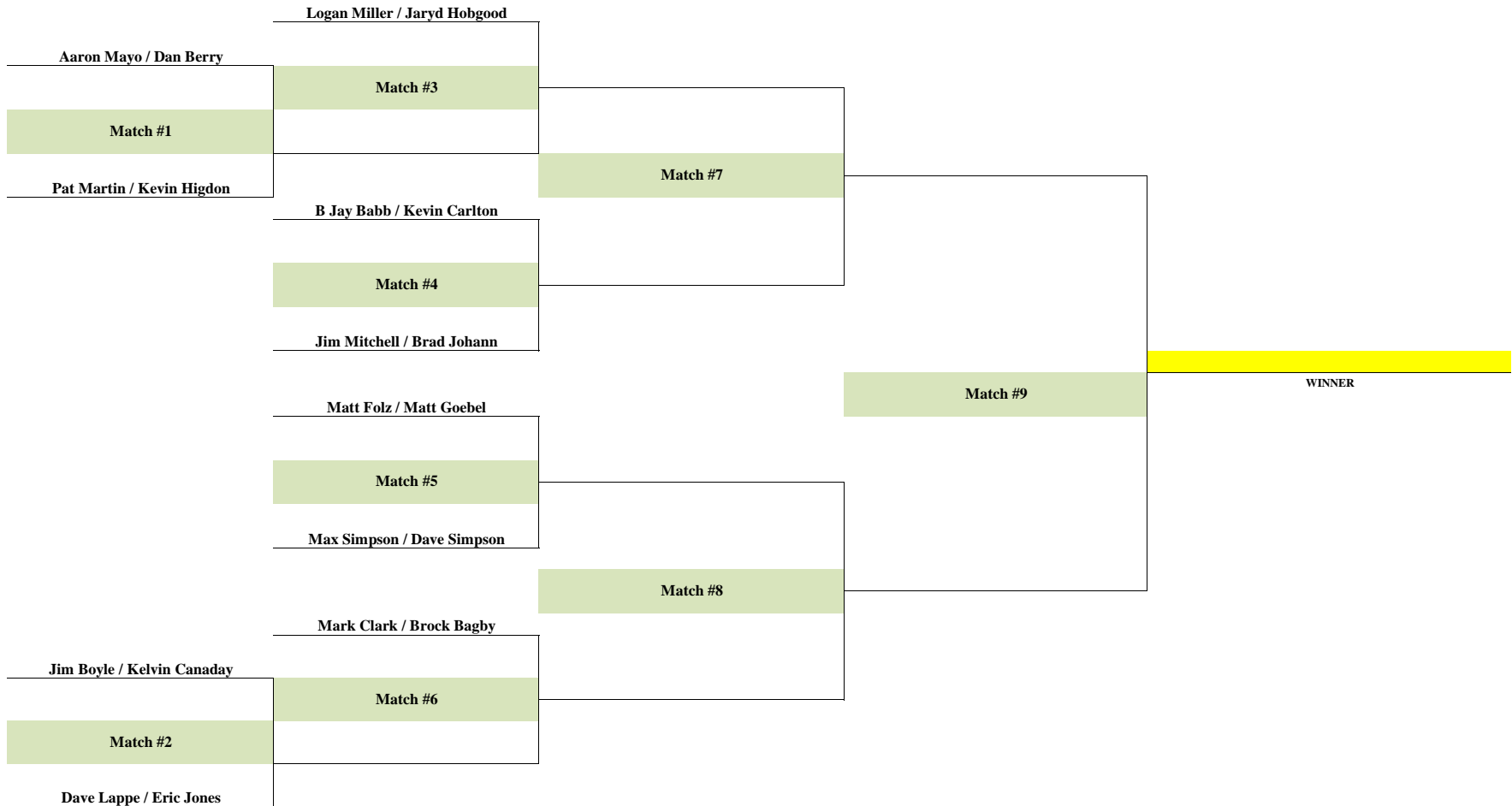

**2021 "Ole Buddy" Match Play**  
**Tournament Rules**

1. The competition will be a 2-Man Best Ball Match Play format.
2. Matches shall be 18 holes playing the front 9 and back 9 of the Helfrich Golf Course. The same 9 may not be played twice.
3. GPS yardage systems are permitted for players use.
4. Players on each team receive their full handicap and the respective strokes on all applicable holes. Before each match begins, teams must declare their respective handicaps with one another. It is **one (1) net best ball, which counts for each team.** Holes are then won, lost or tied based on the best ball score of each team.
5. A match is won when one team is up more holes than there are holes left to play. In the event of a tie, a "sudden death" playoff continuing the match play format shall be played until a winner is finally determined. Playoff holes will begin on #1 or #10 at the convenience of the Helfrich Pro Shop and it being able to accommodate the playing of extra holes.
6. At the conclusion of each match, the winning team shall notify the Tournament Chairman of the outcome via email- [Dtlappe@icloud.com](mailto:Dtlappe@icloud.com)
7. All matches shall be played from the **Blue Tees**, unless individuals are 65 years or older, in which those players have the option to play from forward tees with the appropriate handicap
8. The first round of matches shall be determined by a random draw of players within the bracket. Succeeding matches will follow bracket order.
9. If participation warrants Flights to be established, the tournament shall be Flighted based upon aggregate team handicaps on or about June 20th, 2021. The number of flights (i.e. brackets) will be a function of the number of members participating.
10. Each bracket will consist of at least eight (8), but not more than 16 2-man teams.
11. Given the number of teams competing in each bracket, the construction of a bracket may require some teams be given a bye and move on to the next round of play. The determination of the bye slots and the construction of each bracket shall be decided prior to the draw of teams. Therefore it will be a "luck of the draw" as to which teams get a bye during the

12. Matches shall be scheduled by and at the convenience of the teams. Teams must play and finish their match before the scheduled end-date of the given round of matches. It is highly recommended teams schedule their matches as soon as the round period opens to ensure they be able to finish their match within the specified time period.

13. If a match is not played within the designated time period, the winner of that match will be decided by the Tournament Chairman by a coin flip. A team may concede a match at any time. If a team determines it cannot play within the time period established, it should concede to their opponent assuming the opponent has demonstrated a willingness to set a time to play the

14. No prepared scorecards shall be used or required. When playing their match, teams keep track of who is up (or down) holes as the match is played.

15. **Late for tee time:** If a team is late for his tee time, there is a grace period of up to but not more than 5 minutes. If play begins within 5 minutes of the designated tee time, the player arriving late suffers a loss of hole for the 1st hole and play continues and begins on the 2nd hole. If a player is late for his designated tee time more than 5 minutes, he is disqualified.

16. In match play, a putt or hole or the match may be conceded by a player to his opponent and that concession cannot be withdrawn.

17. Any questions should be directed to the Tournament Chairman - Drew Lappe. The Tournament Chairman and/or the Club Tournament Committee shall resolve any and all disputes. All decisions made by the Chairman and/or Committee shall be final.
